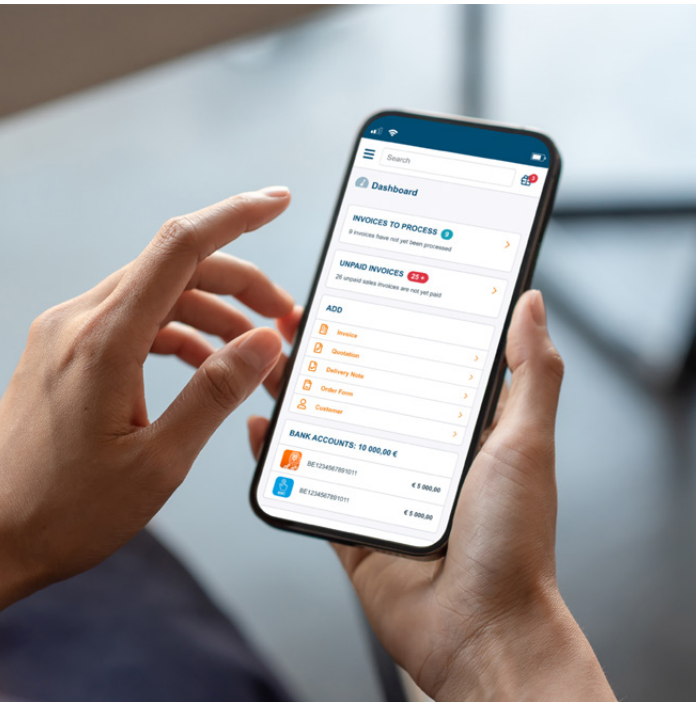

Some background ...

WHAT IS **E-INVOICING?**

E-invoicing, digital invoicing, or electronic invoicing refers to the exchange of invoices between suppliers and clients in an **integrated electronic format**.

As such, e-invoices are not simply scanned paper or PDF versions of an invoice. In fact, they are XML files built according to a universal structure, such as the Universal Business Language or **UBL**. That is why we also refer to them as **structured electronic invoices** or **GEFs**. Software packages worldwide can read and process such GEFs fully automatically.



WHAT IS PEPPOL?

Peppol was originally short for **Pan-European Public Procurement Online**. This is a secure network and collaboration framework for sending and receiving structured electronic invoices. It was developed with European Commission funding to **combat invoice fraud and reduce the VAT gap**. Many countries, including Belgium, decided to use Peppol as the standard for exchanging digital invoices.

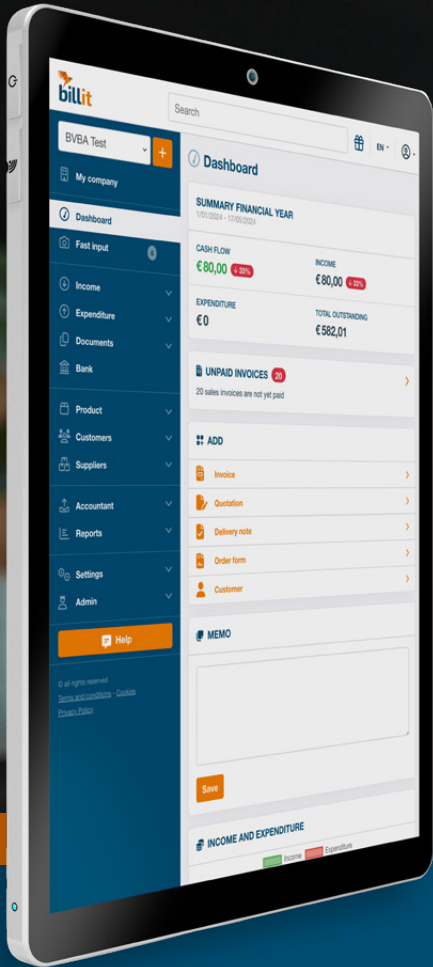
What other e-invoicing networks are there?

Some countries have developed their own e-invoicing systems such as SDI in Italy, ANAF in Romania, KSeF in Poland, OSA in Hungary, etc. Most of the time, the authorities of the country in question mandate the use of these networks.

E-invoices ...

- 1 are created, transmitted, and received electronically
- 2 are fully digital, no scans
- 3 consist of structured data

WHY IS E-INVOICING MANDATORY IN SOME COUNTRIES?



An increasing number of authorities in Europe are mandating e-invoicing under European Directive **2014/55/EU**. The reason for this is to reduce **VAT fraud** and therefore close the VAT gap (the difference between the expected VAT and the VAT received).

In many cases, the plan is to have a second phase **involving the declaration of VAT in real time**, based on the data on electronic invoices. Authorities would no longer have to rely on the honesty of companies in their returns, as VAT would be declared immediately on every purchase and sale. It will make **VAT fraud virtually impossible**. In any case, electronic invoicing will make it easier to detect such practices quickly, both at national and European levels. In that context, we refer to 'VAT in the Digital Age' (ViDA).

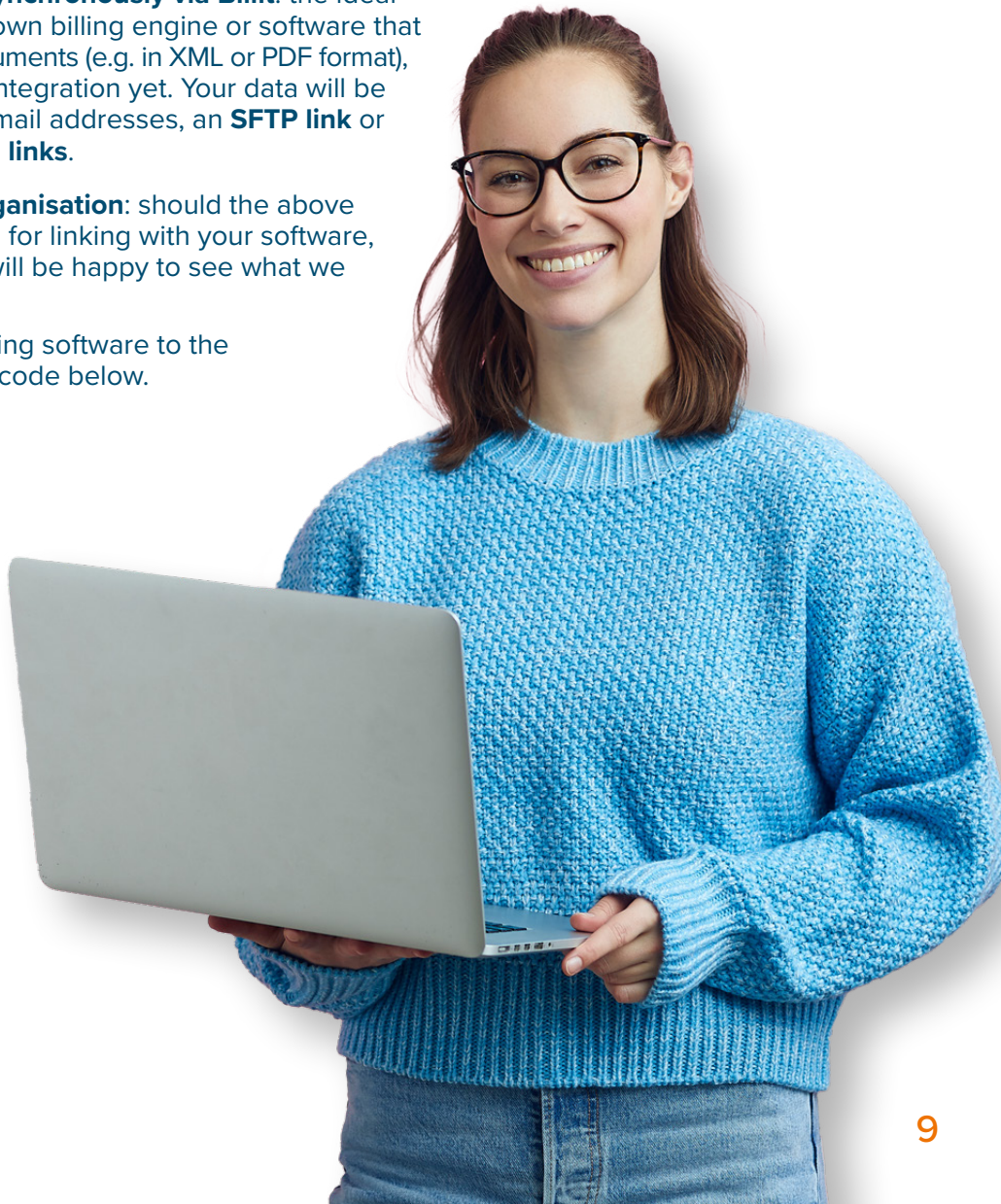
LINKING THE SOFTWARE YOU USE TO THE BILLIT ACCESS POINT

If you are already using your own CRM or invoicing package, you can also use it to link **directly to the Billit Access Point**. This means you can still send and receive invoices in your familiar environment, but also send them securely and in line with international standards via Peppol or other e-invoicing networks.

You can link in different ways depending on your software capabilities and requirements:

- **Creating and sending synchronously via API:** this is ideal if you have your own billing engine or software that can export **data** via API. Feedback will be possible via **webhooks** or **polling**.
- **Creating and sending asynchronously via Billit:** the ideal solution if you have your own billing engine or software that can create and export documents (e.g. in XML or PDF format), but for which there is no integration yet. Your data will be sent to Billit via unique e-mail addresses, an **SFTP link** or **API without synchronous links**.
- **A link tailored to your organisation:** should the above methods not be adequate for linking with your software, no problem, our experts will be happy to see what we can do for you.

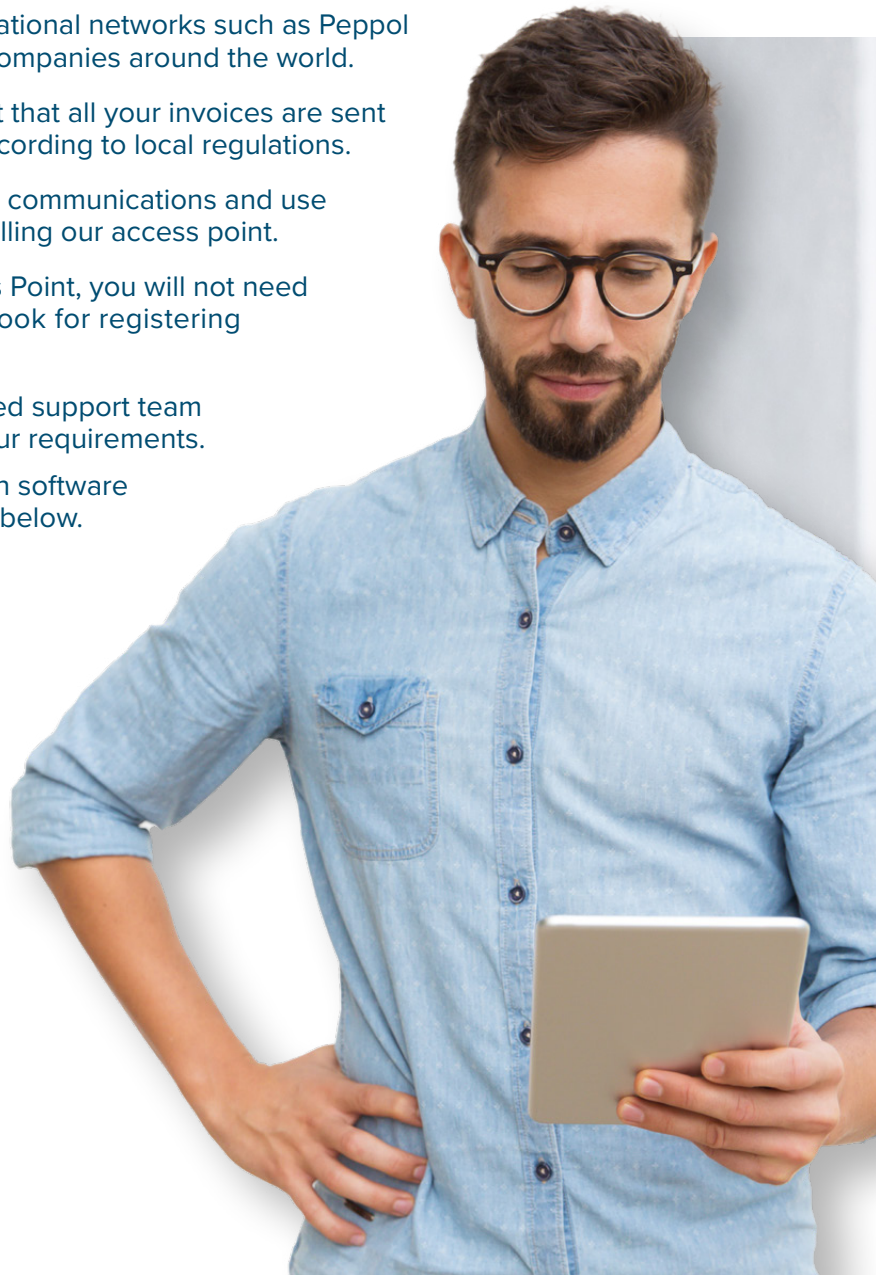
LINKING YOUR OWN SOFTWARE TO THE BILLIT ACCESS POINT

If you are a provider of an (ERP) software package that sends and/or receives invoices, and you do not have access to Peppol or other e-invoicing networks yourself, you can still easily **link to the Billit Access Point**. This way, your clients can send and receive their invoices via the Peppol network or other e-invoicing networks. As you will not have to invest in developing and maintaining your own access point, you can fully focus on the core tasks of your software package.

- **Global interoperability:** secure international networks such as Peppol let you connect with authorities and companies around the world.

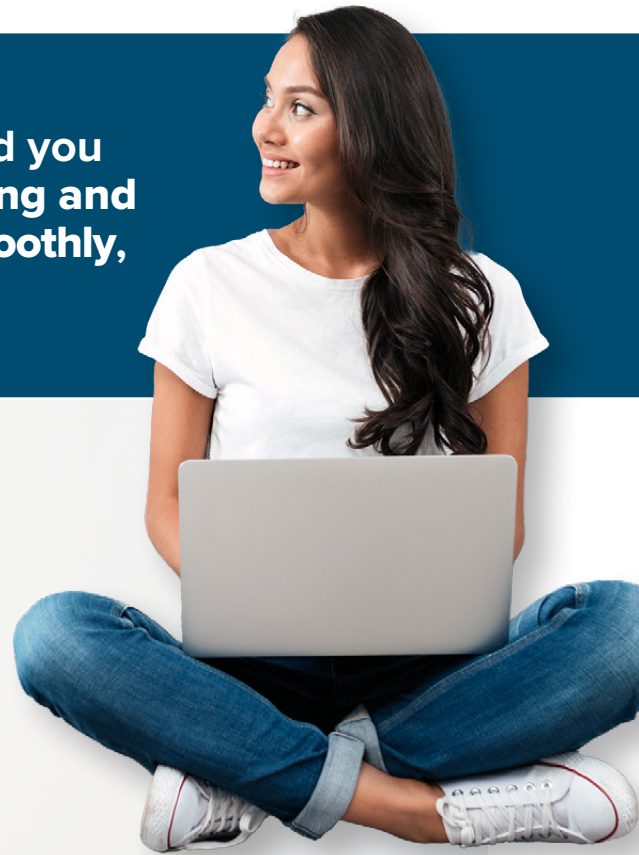

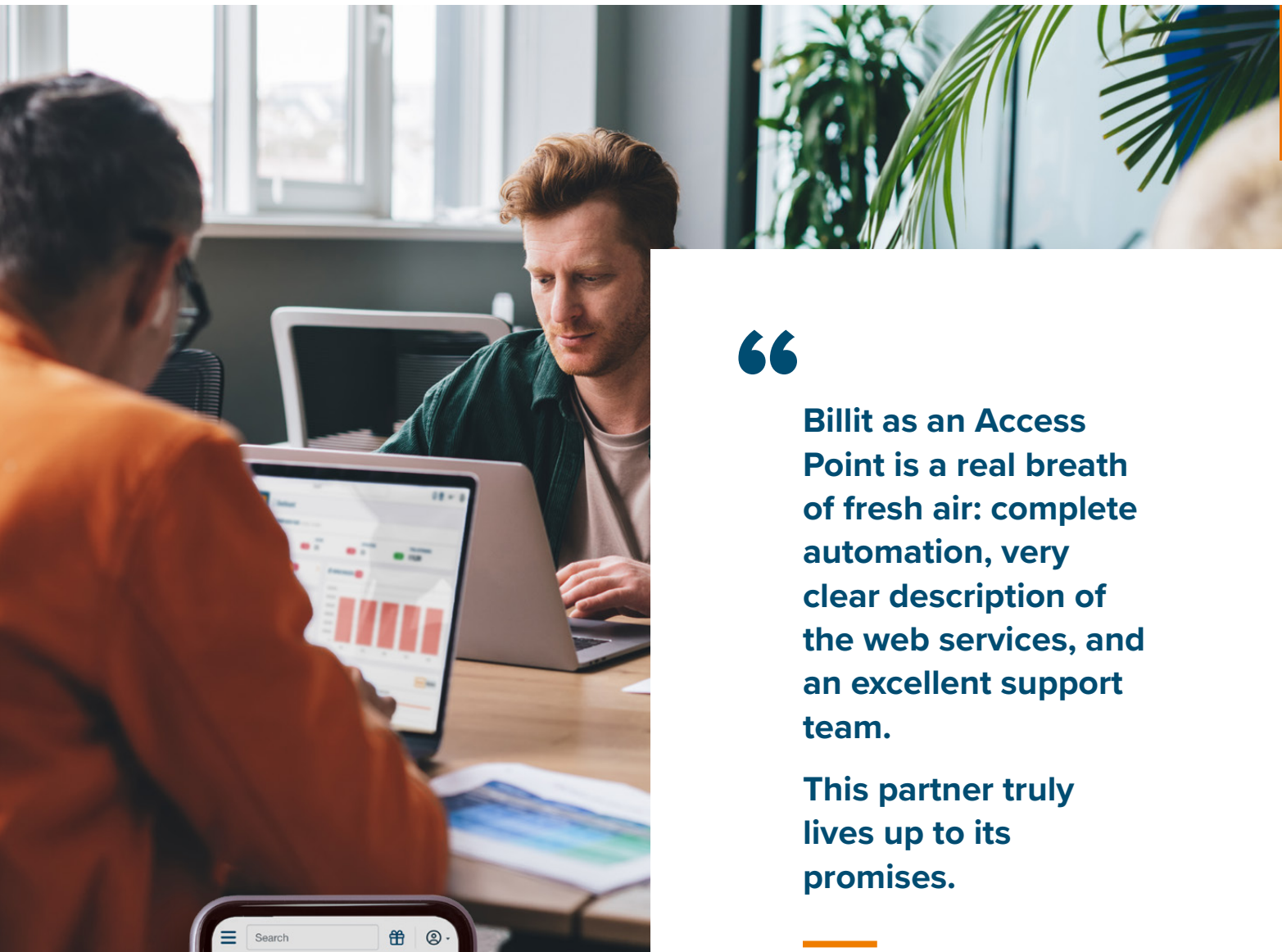

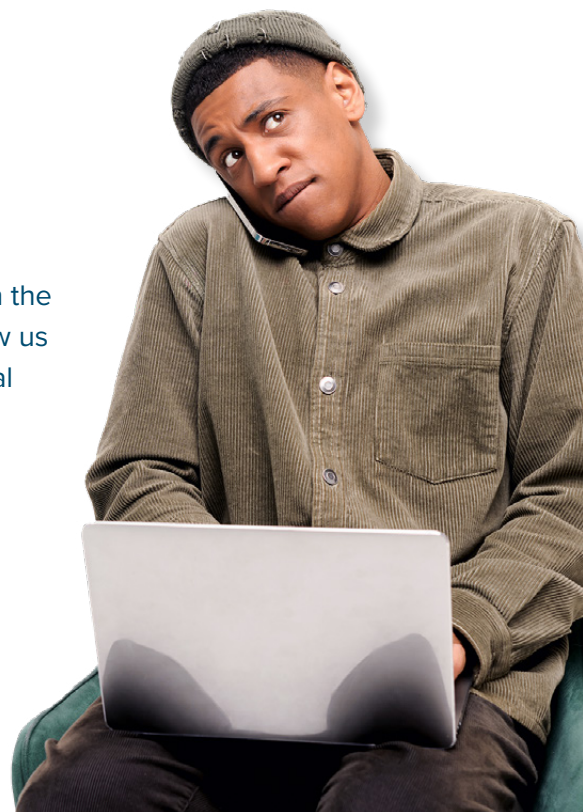
